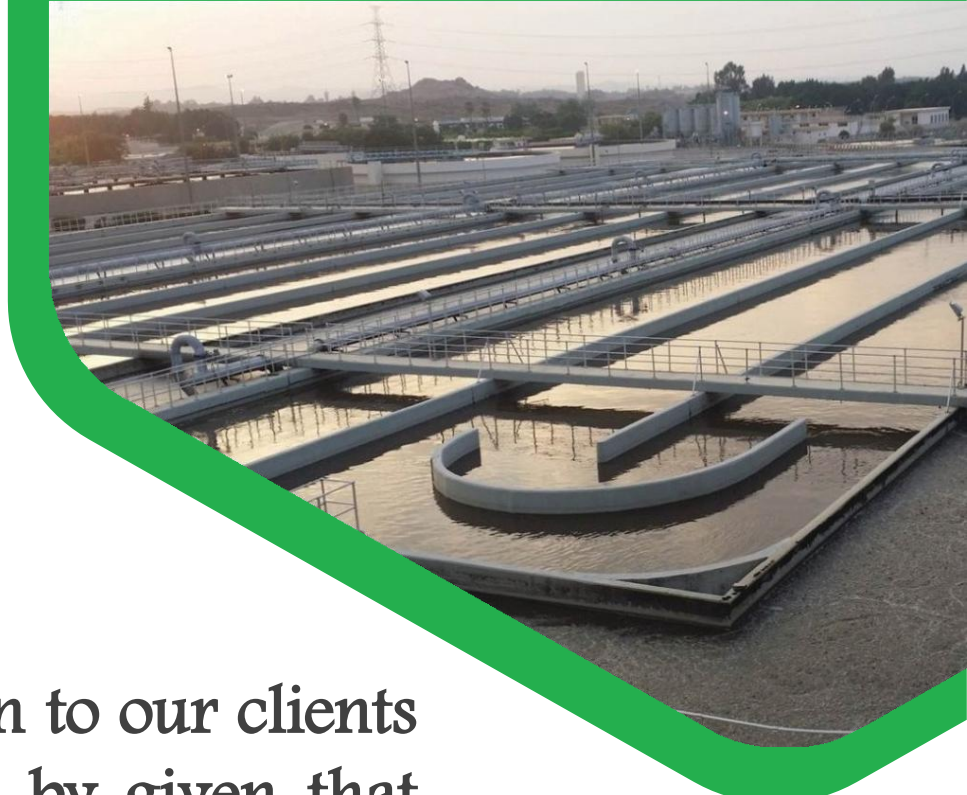

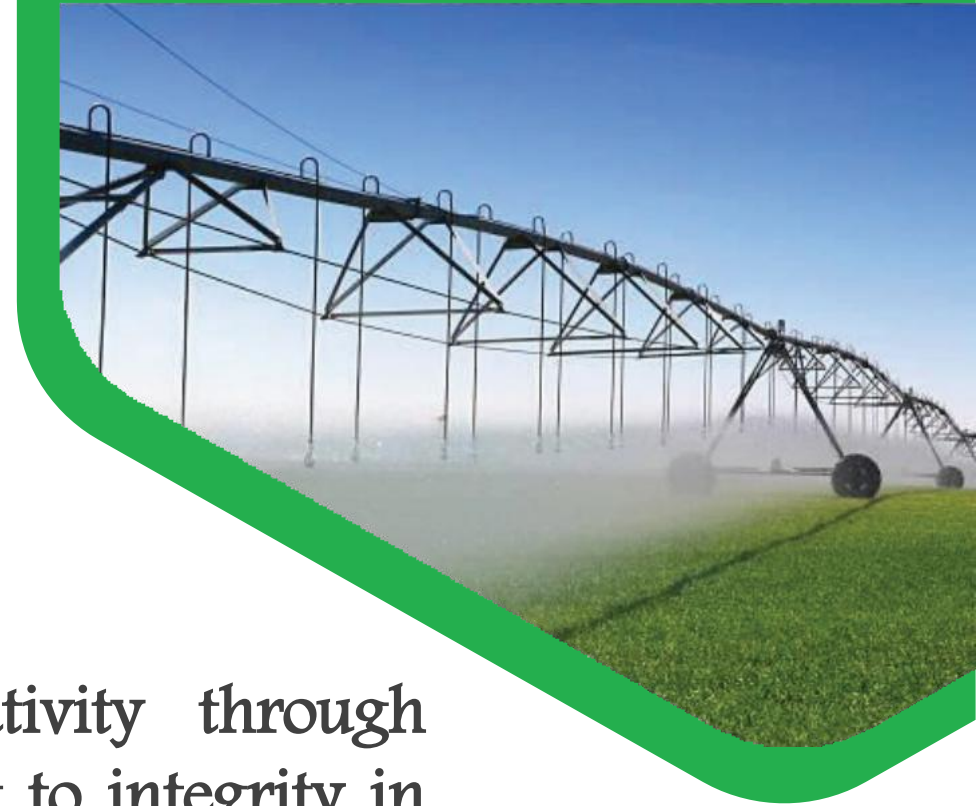

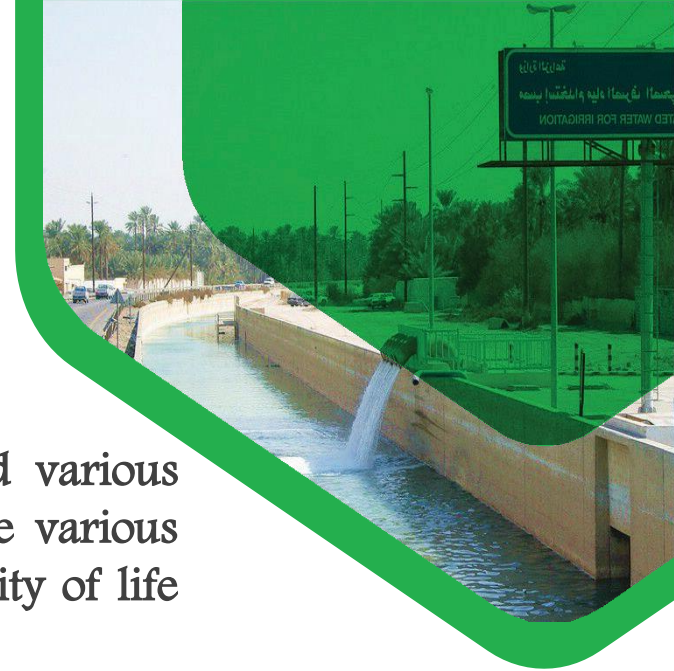


Our Services:
